Dear Members, January 1, 2025

Enclosed are your 2025 dues. An invoice has been included with your amount due. Dues are payable between January 1st and March 1st. Members' dues that have not been paid by March 2, 2025 will be charged a \$50.00 late fee. Members' dues that are unpaid at April 1, 2025 will have their membership terminated. Checks are to be made out to CECO Recreation Assn., Inc. or just CECO is fine. Zelle payments are to be made using ksblock@comcast.net as the account.

This year we have a change to the rules and regulations stating that boat stickers will cost \$10.00 per sticker. The proceeds from the charge will go to the Rod and Gun Club for fish and any repairs that may need to be done to the boating or beach area. The fee for the stickers will not be listed on your invoice. Once you have filled out the boating information on the boating form, add up the number of stickers you are requesting and put that at the top of the form. Underneath that line will be your payment made for the stickers. You can add the payment onto your dues check or with your Zelle payment.

The boating /ATV Golf cart forms no longer need a signature from your insurance agent. We are requiring you send a copy of your declaration page for your boats etc. The amounts of liability required are listed on the forms. Boat stickers must be on by May 1, 2025. If you did not receive a form, they are available on the website www.ceco.rec.

Also enclosed is your 2025 questionnaire. Your questionnaire has been pre-filled. Please check the information carefully, and make any changes. This form <u>must be returned</u> to receive your stickers and guest pass. A self-addressed envelope has been included for your convenience. Your car decals must be permanently affixed to the mid to lower left side (drivers' side) of the windshield. PLEASE REMOVE YOUR OLD STICKERS.

Fees for electric have been listed on your invoice for unnumbered campers. Numbered campers who would like to include payment for electric may do so with their due's payment. Fee for numbered campsite electric is \$10.00 a day or \$175.00 for the year.

If you do not receive your stickers within 2 weeks after your questionnaire and payment have been sent in, please contact Karen Block at 815-530-1817 or email ksblock@comcast.net.

The usual reminders are as follows:

- No guest boat/ATV golf carts allowed at CECO.
- Guest passes are available from any Board Member up to 5 passes. Over 5 passes the member will need to call Frank Pluth.
- Garbage pick-up is currently stopped. Please take your garbage with you at this time. Service will resume again in late April.
- If you see anything questionable, please notify a Board Member or the Caretaker. In case of an emergency call 911 and tell the dispatcher to dispatch Coal City.
- All boats without a current sticker by June 1 will be picked up and held. If your boat is picked up without a sticker there is a \$50.00 fine to collect it. If it is not picked up by July 1, 2025 the boat will then be available for purchase. Fees collected will be turned over to the Rod and Gun Club.
